In pursuant to the proposal submitted by the institute with reference to the letter no.1 to the university for approval of renewal of affiliation for the academic year 2022-23, a local Inspection committee was appointed by the university vide reference letter no.2.

The report submitted by the said Local Inspection Committee to the university after visiting your College / Recognized Institute, as per order received.

After scrutinizing and inspecting Hon. Dean/Board making recommendation regarding renewal/natural expansion of the complex and student admission, the said report was submitted to the Hon. Vice- Chancellor, Hon. Accreditation is granted on behalf of vidya parishad. Accordingly the continuation of affiliation /Natural growth [continuation of affiliation /Natural Growth] of the subject course mentioned in the accompanying table is being approved as per section 114(1) of the Maharashtra Public University Act 2016 for the period shown before it.

Pursuant to the above, we hereby inform you that and please note that it will be mandatory for you to fulfill the requirements as per NCTE Norms and standards -2014 and approval of the relevant authority will also be required.

The Affiliation is given to your college is only for one academic year i.e. for the academic year 2022-23 and it will be mandatory for you to renew the said recognition from time to time.

You are also informed that as per section 108 of the Maharashtra Public University Act 2016 it is mandatory for you to fulfill the conditions/errors notified by the University for Affiliation and accordingly we request of your college / accredited institution.

The conditions/defects should be fulfilled in perfect form and the fulfillment report along with the necessary documents should be sent to the Affiliation department of the university within the three months however before submitting the proposal for renewal of affiliation for the academic year 2023-24 kindly note that if you do not submit the Eligibility report within the said period, no proposal of your college for the academic year 2023-24 will be accepted and you will be fully responsible for the same.

College where the conditions of principal, librarian, not fulfilled in their college will be filled up in 3 months with the content renewal /natural extension of affiliation is being approved along with student admission for academic year 2022-23 on the condition of furnishing an undertaking on non-judicial stamp paper of Rs.100/-

However, for the academic year 2022-23 approval for renewal of affiliation / Natural extension is being granted only to those colleges which have been mentioned as no admission for first year and / or second year directly in the accompanying such colleges should not admit students for the first year and directly for the second year. However, such colleges / Institutes should pay Rs.100/- only along with submission of a notarized undertaking on non-judicial stamp paper, supporting documents showing that adequate efforts have been made to fill the vacancies and accordingly submitting a proposal to the university for permission to admit students will be considered for admission but student should be admitted only after the final approval of university.

Also, in the case of colleges whose related cases are still pending in the hon. Court, it is also requested to note that for such colleges the action will be taken subject to the order of the hon. Court.

Please note that NAAC/NBA will be mandatory for college.

It is requested to take action accordingly in regard to the above stated.



**Revised Order**

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the Shri Rajee Chhatrapati Sambhaji B.ED. College, Shri Mangal, Murti Bahuuddeshiya Krida Mandal, Plot No.347, Khasra No.2113, Krishak Bhavan, Navi Peth, Shivaji Chowk, Dist. Jalgaon 425001, Maharashtra by affidavit dt. 09.01.2015 has consented to come under new Regulations and sought for two basic units in B.Ed. which require additional facilities

3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised formal recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Shri Rajee Chhatrapati Sambhaji B.ED. College, Shri Mangal, Murti Bahuuddeshiya Krida Mandal, Plot No.347, Khasra No.2113, Krishak Bhavan, Navi Peth, Shivaji Chowk, Dist. Jalgaon 425001 Maharashtra for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
  - a) Sanctioned programmes along with annual intake in the institution;
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last quarter.
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students.
  - f) Available infrastructural facilities.
  - g) Facilities added during the last quarter.
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i) The affidavit with enclosure submitted along with application.
  - j) The institution shall be free to post additional relevant information, if it so desires.
  - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.
